## 11. Toxicological Information

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet. Symptoms or affects may arise if the product is mishandled and overexposure occurs.

However, this product contains small amounts of vinyl acetate monomer. ACGIH evaluated vinyl acetate as an A3 ó Animal Carcinogen: the available evidence suggests it is not likely to cause cancer in humans except under unusual exposure. The IARC monograph indicates othere is little evidence in humans for carcinogenicity of vinyl acetate. There is limited evidence in experimental animals for carcinogenicity of vinyl acetate. This would normally place a substance in IARC category 3. However, because vinyl acetate is metabolised to acetaldehyde, an IARC 2B classification has been assigned.

#### **Acute Effects:**

**Ingestion:** Swallowing can result in nausea, vomiting and irritation of the gastrointestinal tract.

**Inhalation:** May be an irritant to mucous membranes and respiratory tract.

**Eye contact:** May cause eye irritation.

**Skin contact:** May be a skin irritant.
